### **Green Timber Tree Farm Group Management Policy**

Green Timber Consulting Foresters, Inc. has establised the Green Timber Tree Farm Group to provide a streamlined and cost-effective way for private landowners to achive 3<sup>rd</sup> party forest certification. It is the intent of Green Timber Consulting Foresters, Inc. to maintain, operate, and continoulsy improve the Green Timber Tree Farm Group so that the benefits of forest certification can be realized by the Group Members and to ensure a high level of sustainable forest management is being achived.

### **Green Timber Consulting Foresters, Inc. Agrees To:**

- 1. Maintain and operate an integrated Group Management System for maintaining conformance to the AFF Standards of Sustainability, the ATFS IMG Standards, and other requirements of ATFS certification.
- 2. To continuously improve the Group Management System and support improvement of sustainable forest management on Forest Management Units enrolled in the Group Organization's Group Certificate.
- 3. Provide at least 1 newsletter per year.
- 3. Notify group members at least 3 months in advance of any fee changes.
- 4. Maintain strict confidentiality of any proprietary information.
- 5. Pay all applicable fees to the American Tree Farm System:
  - a. Annual administrative fee.
  - b. Fees associated with 3rd party certification.

### **Group Members Agree To:**

- 1. Comply with American Forest Foundation's Standards of Sustainability and implement corrective and preventive actions (if any) actions established by the Group Entity. Copy available upon request or at www.greentimberforestry.com
- 2. Utilize the management planning services of Green Timber Consulting Foresters, Inc. or a pre-approved alternative service.
- 3. Utilize the timber sale administration services of Green Timber Consulting Foresters, Inc. or a pre-approved alternative service.
- 4. Notify Green timber Consulting Foresters, Inc. if/when ownership status is changed or acres are added or subtracted from the Tree Farm.
- 5. Pay annual dues at 10 cents per acre for Tree Farms that are 1,000 acres in size or larger. Tree Farms less than 1,000 acres will not be charged annual dues.

In addition, the Michigan Tree Farm Committee has agreed to provide Group Members with a Tree Farm Sign, if requested.
